To exhibit a piece in this show, please bring the artwork to the Full Circle Gallery, 29B Eglin Pkwy SE, Fort Walton Beach, FL on August 10th-14th from 4:00pm-6:00pm along with the submission form at the bottom of this post and a 3-5 sentence artist statement. If you do not live locally, you are welcome to ship your piece. In this case, you will need to print the submission form and send it along with a check with funds for return shipping. If your piece is sold during the show, your check for shipping will be voided and a check for payment will be sent. If the check is not sufficient to ship the piece back, the piece will remain at the gallery for one month. After this time, the piece will become property of Full Circle Gallery.

Each person is allowed one submission no larger than 24x36 inches. Submissions can be in any medium. All pieces must be at the gallery by 6:00pm on August 14th, ready to hang with wires or you will not be able to participate in the exhibit. Dealer- Artist Sales Agreement

This is a contract between the Artist (signed below) and the Full Circle Gallery LLC to exhibit and sell artwork. The Full Circle Gallery (hereinafter referred to as the Dealer) acknowledges receipt of the consigned artwork(s) outlined in the appended list of consigned artwork. The above printed name (hereinafter is referred to as the Artist). The Dealer, as an agent for the artist, agrees to exhibit and offer for sale artistic works by the Artist under the following terms and conditions.

1. The Dealer shall receive a commission of fifty percent (50%) of the retail sales price collected on each work sold. If the Dealer refers a buyer to the Artist for the purpose of securing a commissioned work or if the Dealer negotiates special project commission agreements with the clients or their representatives for the creation of artwork by the Artist, the Dealer will be entitled to a commission of fifty percent (50%) of the sales price collected on the artwork. In addition, with respect to the work sold by the Artist as a direct result of introduction of the work by the Dealer, the Dealer shall be entitled to receive fifty percent (50%) of the sales price of the work unless the Dealer agrees otherwise in writing.
2. Reasonable care shall be taken of all consigned work while in the Dealer's possession. The Dealer will only cover the full wholesale value of the artwork if it is damaged by fire or theft.
3. **All work must be picked up by August 31st between the hours of 11:00am and 6:00pm. The gallery will not store work after that date for any reason.**
